Present were Ruah Swennerfelt, Louis Cox, Ed Harris, Jean Rosenberg, Tom Baskett, Grace McGrath, Spence Putnam, Fran Putnam, Joe Garren, Karen Nawn-Fahey, and Grace Seale.

**20:11:01 Opening Worship** Worship began with a time of silence. Jean Rosenberg shared readings from Isaac Pennington and George Gorman.

20:11:02 Review of Minutes Minutes from the October meeting were reviewed and approved.

20:11:03 Report from the committee on establishing a Zoom account Ed Harris reports the Zoom account is set up. He will create and distribute a document with instructions for routine use. He emphasizes that the account permits one user at a time; hosts are reminded to check for time conflicts. The information will also describe actions needed by host and participants should a "Zoom bomb" event occur. This document is for use by Meeting members, not for public sharing.

Friends expressed appreciation for Ed's work in setting this up, as well as all these months during which he has been the Zoom host for the Meeting.

**20:11:04 CoClerks' Report** Joe Garren reported that Middlebury Friends Meeting and all NEYM Meetings received a copy of the NEYM treasurer's letter to FUM explaining the new NEYM policy on its annual membership contribution to FUM's budget. The letter further expressed that NEYM continues to be deeply exercised about our membership in FUM because of the section of the personnel policy which limits marriage to heterosexual relationships and requires staff members to refrain from sexual relationships outside that narrow understanding. We are clear that the FUM personnel policy causes harm to LGBTQ+ Friends, as well as all Friends who are sexually active outside heterosexual marriage. Furthermore the policy suppresses the ministry of these Friends, causing loss to the wider body. We seek forgiveness for the extent to which we are complicit in this.

20:11:05 Treasurer's Report Karen Nawn-Fahey presented the monthly Treasurer's Report. In response to a question about a discrepancy between budgeted and actual income, she notes that in the past some who donate higher amounts may make those donations close to the end of the calendar year.

She reiterates that Friends who want funds from their contributions to be withheld from FUM are requested to communicate that to her promptly.

\*The surplus funds from donations to the Community Supper remain. It was agreed that this money go to Charter House Coalition, which runs the Community Suppers.

\*First Day School participants have been discussing the possibility of funds not spent for materials this year being used instead toward benevolences, and wonder about how that might be accomplished. Since FDS is under the care of the Worship and Study committee, it was suggested that a member of that committee might visit the group to consider options. Great regard for the FDS participants' care for others was voiced. After discussion, it was decided that Karen and Lianna Tennal will work together to determine a way forward, and then communicate with the Finance Committee.

\*Karen presented the 2021 proposed budget in a shared-screen format so all could readily follow. She will send this proposed budget to the listserv and solicit comments. Specific questions arose about:

Middlebury Clergy group dues: Tom Baskett will seek clarification from the clergy group about current status.

Where should fees for Zoom account appear? Options include line #17, or possibly establishing a new line item for this \$150 expense. Finance Committee will discuss.

The Clergy Rental Fund was discontinued last year and funds reallocated to the Warming Shelter and Community Housing. The Finance Committee will propose how to allocate them in the 2021 budget.

Ruah Swennerfelt advocates consideration of an increase to budgeted amount for Quaker Earth Witness, Line #46. After discussion there was agreement that \$50 from the contingency funds be allocated to this benevolence.

Hospice Volunteer Services, Line #38, is now known as End of Life Services. The 2021 budget will reflect this name change.

20:11:05 Earthcare Committee Ruah Swennerfelt reports the committee has begun consideration on how we come to live into the <u>Call to Urgent Loving Action for the</u> <u>Earth and her Inhabitants</u> letter from NEYM, described in October.

**21:01:01** Opening Worship Following a time of silence, Ruah Swennerfelt offered a prayer for centering, grounding, and our full presence as we gather. Joe Garren read a reflection contrasting human wisdom and reason, an intellectual process, with the sense of the Meeting, the work of the Spirit, seeking a higher and greater truth (from writings of Eden Grace in NEYM Faith and Practice).

21:01:02 Review of Minutes The minutes from November were reviewed and approved.

**21:01:03 Clerks' Report** Jean Rosenberg reported on the ad hoc committee that researched, recommended, registered, and guided our initial use of the MFM Zoom account. Ed Harris has prepared instructions and guidelines for use, which he will share upon request.

The work of this committee is noted with gratitude from all of us.

Jean also spoke about a letter from Mark Moss, a former member, now of Greenville, NC. He serves on the Board of Quaker House in Fayetteville, which "is a manifestation of the Friends' Peace Testimony" for the military at nearby Fort Bragg, as well as via phone for those in other locations. This group offers a wide variety of services, including a GI rights hotline, domestic violence counseling, education on conscientious objection and military issues. He has requested thoughts about ways in which Quaker House can engage more fully with the wider Quaker community. Ideas may be sent to Jean who will pass them on, or directly to Mark at 1607 Rondo Dr, Greenville, NC 27858.

**21:01:04** Treasurer's Report All statements in this report are as of October 16, 2020. From September 19 through October 16, 2020, the Meeting had member donations of \$3645, including \$1125 for the Community Supper. From September 19 through October 16, 2020 Meeting expenditures totaled \$2746.83, including \$133.33 for Children's Program Coordinator, \$60 for Childcare, \$800 to NEYM, \$125 to NWQM, \$662.50 to Havurah, \$366 to Pratt's and \$600 to KNF to reimburse for Community Supper expenses. When all these checks clear, the checking account balance will be \$7639.83 (includes RCH and VFV funds).

Current balance of Vision For Vermont funds: \$324.85 Current balance of the Rachel Carey Harper Fund is \$630

Report of 17 January 2021 submitted by Karen Nawn-Fahey noted, appreciated and approved.

- NWQM has suggested that Monthly Meetings consider reducing their (NWQM) contributions by one half. Lianna Tennal adds that NWQM has requested Monthly Meetings to use such funds toward local endeavors; the Finance Committee will discuss how this can be accomplished.
- The proposed 2021 budget was reviewed, discussed, and approved. Great appreciation was expressed to Karen Nawn-Fahey for her faithful attention, good humor, and hard work as treasurer.
- The books of 2020 will go to Spence Putnam for review later this month.

### 21:01:05 Worship and Study Committee Report

- Lianna Tennal reported the Friendly Forum on Spiritual Friendship was not only well-attended but also received positive comments. The next Friendly Forum meetings are 28 Feb with Jean Rosenberg on Hebrew Prophets, and 28 March with Don Peabody and Lianna on Engaging with Indigenous Peoples.
- Shulamith Clearbridge requested permission to use the Zoom account for Experiment with Light presentations. There was agreement on this use.
- MFM receives 35 paper copies of NWQM newsletter, which were formerly placed on a table at Havurah House for perusal or taking. There was consensus that while we are not meeting in person this mailing could stop. Lianna routinely sends this newsletter out to the Listserv, and individuals can request paper or direct email of these from NWQM.

**21:01:06 Pastoral Care Committee** Grace McGrath reported 16 participants in the gathering facilitated by Fran Putnam providing an opportunity to share reactions

and responses to recent events. There were many positive comments, and interest expressed in further similar gatherings. The Clerks, Tom Baskett, Grace M, and Fran will discuss possible future dates and formats for these.
