21:06:01 Opening Worship Jean Rosenberg read a passage from Margaret Fell [b 1614, d 1702], with a time of quiet following.

**21:06:02** Review of Minutes Minutes from May Meeting for Business were reviewed and approved.

### 21:06:03 Clerks' Report

- The summer Meeting for Business is 18 July 2021, 8:30 AM. There's no Meeting for Business in August.
- We are reminded of NEYM Sessions, 7-12 August, again held virtually this year. Registration is online (<u>neym.org</u>) and fees are as Friends are able or led.

The Clerks are continuing to discuss the possibility of gathering in person to participate in some on-line sessions. In particular the Opening session Saturday the  $7^{\text{th}}$ , as well as Monday the  $9^{\text{th}}$  when John Calvi will speak, and on Tuesday the  $10^{\text{th}}$  with Hanifa Nayo Washington's interactive presentation seem ideal for this format.

**21:06:04** Technology Committee This committee considered multiple factors toward the goal of combining in-person and remote gatherings, requiring both attention to detail and coordination with Havurah House.

The upgrade in Comcast internet service to Havurah House has been accomplished. Maximizing hearing and seeing for both physical and remote attendees was carefully considered when locating the connections.

Among the required MFM purchases are a large flat-screen TV, a Chromebook. and associated smaller items. The monthly cost for the broadband service has gone up; discussion followed about the potential increase in MFM payments to Havurah House [please refer to Treasurer and Finance reports 21:06:05].

For this system of concurrent in-person and Zoom meetings to become fully functional, substantial practice, and the inevitable associated trials-and-errors, is necessary. Abundant generosity and patience are needed on everyone's part.

Yet unanswered questions include, though are not limited to, a system of volunteers for weekly set-up and how First Day School can best meet children's needs and protect those who are unvaccinated.

Ed Harris's invaluable expertise in determining necessary equipment and most advantageous arrangements is acknowledged with tremendous gratitude.

There are requests for the earliest possible in-person meetings to begin, given that Friends not able to join electronically have experienced such a long interval without being at Meeting.

Discussion followed about gathering both in-person and Zoom until the system to combine them is operational. Other local worship groups have also been experimenting with similar logistics.

### 21:06:05 Treasurer's and Finance Committee Reports

From Karen Nawn-Fahey: All statements in this report are as of June 30, 2021. From May 17 through June 20,2021 the Meeting had member donations of \$1775. From May 17 through June 20, 2021 Meeting expenditures totaled \$335.33 including \$133.33 for Children's Program Coordinator, \$40 for Child Care, and \$162 for oneyear PO box rental.

When these checks clear, the balance in the checking account will be \$7766.67.

The current balance of Vision for Vermont funds is \$324.85.

The current balance of Rachel Harper Carey funds is \$630.

Discussion followed about meeting the fixed expense up to \$700 for equipment to be purchased and the \$30 increase in rent covering costs of broadband. These can be covered by a combination of reserve and Rachel Harper Carey funds, and the one-time \$125 reduction in what is sent to NWQM.

Friends agreed on all these.

Karen Nawn-Fahey's service to MFM as Treasurer , now concluding, was acknowledged and thanks were warmly expressed.

### 21:06:06 Earthcare and the Call to Urgent Loving Action for the Earth and her Inhabitants Committees

These committees are working together to address several closely related issues of particular and timely concern.

The committee requested the Meeting participate in a campaign to purchase solar panels at the Bristol Community Solar Project to benefit the Clemmons Family Farm, an African-American arts and cultural foundation in Charlotte [www.clemmonsfamilyfarm.org].

This project is jointly sponsored by Interfaith Climate Action Network (ICAN) and Vermont Interfaith Power and Light (VTIPL) The intersection of racial justice and concern for climate make this project a rare opportunity to work locally for climate justice. Commitment to purchase six panels has already been made; an additional \$2800 is sought for the purchase of ten.

After discussion there was agreement to MFM contributing \$1000 toward this project.

The Call to Urgent Loving Action Committee reports an ongoing process about their scope of action. They seek to discern their ongoing focus of attention: local, regional, national, global. This committee will send regular summaries to MFM as their process evolves.

### 21:06:07 Rachel Harper Carey Fund Committee Report

Tom Baskett reported the committee considered requests for funds for equipment to provide remote access for gatherings at Havurah House and for solar panels at the Clemmons Farm. The committee agreed that both meet criteria for use of these monies, and following discussion, these decisions were affirmed by Friends.

The expenditure of 200 for equipment and 430 for the solar project would use the current funds entirely. Replenishing these funds in the future would provide MFM with the flexibility to meet other requests that may be received.

### 21:06:08 Nominating Committee

The slate of nominees was reviewed and approved.

Spence Putnam reported that Tom Baskett agreed to continue as MFM representative to Middlebury Area Clergy Association [MACA].

A volunteer for newletter editor is sought; interested persons may communicate with the Nominating Committee or the Clerks.

Win Colwell's years of service to the Meeting in this role are again noted with great regard.

The work of the committee is acknowledged with appreciation.

**21:06:09** Committee on Apology to Native Americans Lianna Tennal reports this group has met, and finds many possible directions for actions. She will circulate information on a regular basis.

21:06:10 Acknowledgement Today concludes Jean Rosenberg's service over many years as Co-Clerk. There were multiple expression of gratitude for her leadership, skills, and good humor.

### 21:06:11 Closing worship

Several moments of silent worship concluded this gathering.
