21:11:01 Opening Worship

Following a time of silence, Joe Garren read a selection from *Friends for 300 Years* by Howard Brinton.

21:11:02 Agenda Review

The agenda was briefly reviewed and accepted.

21:11:03 Review of Minutes

The minutes for the 17 October Meeting for Business were reviewed and approved.

21:11:04 Co-Clerks Report

1] Passage of the Month

Joe shared a portion of the passage of the month from the draft chapter of Ministry and Counsel (NEYM, *Faith and Practice*). This is for our monthly meeting and applicable to the Meeting for Worshipwith a Concern for Business, the Worship and Study Committee, and the Pastoral Care Committee.

From paragraph 12:

"In Friends' worship there is an interplay between gathered silence and vocal ministry. M&C encourages spiritually-grounded ministry and engages with Friends in whom it is a consistent gift. It may need to offer loving personal reminders to Friends of the purpose of space between messages, the importance of silence to Quaker practice, or of too- frequent speaking or singing by an individual. Ministry & Counsel can guide the community in becoming sensitive to cues that an offering of sung ministry may or may not be an invitation for other worshippers to join in. It also encourages Friends who may be reticent to speak to respond to the Spirit's prompting to offer vocal ministry."

2] NEYM Bayard Rustin Fund for Support and Action (approved Sessions 2021)

The intention of the new fund is to "support LGBTQIA+ organizations in East Africa, Central and South America, India, the Caribbean, and North America." The body also

approved allowing monthly meetings to redirect (to this fund) the portion of their Yearly Meeting contribution which would otherwise go to Friends United Meeting. This redirection will "assist monthly meetings in their witness as well as target support to initiatives that resist current anti-trans youth legislation by increasing the visibility of efforts and opportunities for collaboration across NEYM." The Fund is open now and ready to receive contributions from monthly meetings and individuals. Do we want to send our FUM contribution to this Fund

There was discussion and clarification about MFM response to this fund as well as individuals options for support and contribution. This fund was approved at sessions 2021. From this time forward, monthly meetings who wish to prevent any part of their contributions to the Yearly Meeting from going to Friends United Meeting should now send in their full contribution, but indicate in a letter to the Treasurer and Accounts Manager that they wish to have the applicable percentage (currently 1.4%) redirected to the Rustin Fund. After discussion, it was the sense of the meeting that this issue should be brought back to the January business meeting for further discussion. Jean requested that Joe send out information about this fund to the listserve prior to the January business meeting.

21:11:05 Treasurer's and Finance Committee Reports

1] Laura Assermily reported:

All statements in this report are as of Nov 21, 2021. From Oct 18, 2021 through Nov 21, 2021, the Meeting had robust member donations of \$6,125 in response to our call to for end of year donations on which we depend to meet benevolences paid in Nov. We also had \$14 in book sales organized by our librarians to cull our collection. From Oct 18, 2021 through Nov 21, 2021 the Meeting expenditures totaled \$4,404.70 including \$3,925 for the bulk of our benevolences, \$133.33 for Children's Program Coordinator, \$158.89 for Zoom, \$24.37 for First Day materials, \$38.11 for worship and study materials, and \$125 for the 2021 directory printing (50 copies). When these checks clear, the balance in the checking account will be \$15,687.11 The meeting will need to determine how it wants to designate the \$200 allocated as a 2021 benevolence for "warming shelter/transitional housing."

Discussion was had about \$200 benevolence that would have gone to the warming shelter which is no longer housed at Memorial Baptist Church. Charter House has absorbed the function of the warming shelter. After discussion, it was the meeting's sense that \$200 should be sent to the John Graham Shelter to support ongoing emergency/transitional housing needs.

2] We will also need to review and approve a budget for 2022 as proposed by the Finance Committee. A separate email was sent out in advance explaining it. You can

compare it to the current budget and see we are proposing one very similar to the last one. Expenses have been adjusted with the net result being almost identical to last year. We are presenting a level funded budget. We can decide how the Meeting would like to allocate benevolences. Our approach has been to support Quaker organizations and local ones, especially those with ties to our attendees. Ruah is recommending adding Abenaki Helping Abenaki (http://www.abenakitribe.org) and I am recommending adding Turning Point Center of Addison County (https://turningpointaddisonvt.org). We made a decision to allocate the \$100 for End of Life Services to Bolivia Friends. We can decide if we want to carry this over as an annual benevolence.

The 2022 budget will be brought back to the January Business Meeting for approval.

Current balance of Vision for Vermont Funds: \$324.85

Current balance of Rachel Carey Harper Funds: \$5,000

Discussion was had about the 2022 proposed budget. Laura explained that the new budget is almost identical to the 2021 budget.

Remaining 2021 Vision for Vermont funds will go for support of the Abenaki people.

Remaining 2021 Rachel Carey Harper Funds will be spent on Bolivian End of Life Services. This fund will also be used in the future for unbudgeted activities and concerns that fall within the criteria of the fund (e.g., start locally and go global).

Proposal Ruah recommended that MFM continue to support Abenaki people with a benevolence of \$150.

Discussion about Middlebury Area Clergy Association dues - Laura will retain a line item for this in the next budget.

Discussion about the MFM directory and costs associated with it. There are funds within the proposed 2022 budget to cover printing costs, whether it is reprinted annually or biannually.

Proposal Laura recommended that \$150 be allocated for support of the Turning Point organization.

The Finance Committee is open to receiving additional benevolences. Individuals with a concern should contact Laura or any member of the Finance Committee with their ideas.

21:11:06 Committee Reports

Nominating Committee Report: Tom Baskett reported that Karen Way has accepted the nomination to be the rising co-clerk. She has been a member of the New Brunswick Meeting for 40 years as well as belonging to the NY Yearly Committee. She was approved. Worship and Study Committee Called Meeting Report on Covid 19 Protocol

Cheryl Mitchell reported on the draft document for the protocol for meeting in person with Covid 19 transmissibility and weather in mind. (See following article).

Discussion was held about this. Concerns were expressed about whether or not to include a Zoom link online in the MFM website. This will be addressed at a future business meeting.

Ruah Swennerfelt and Jean Rosenberg are the current contacts for information regarding in-person or remote worship (and other questions about MFM)

Discussion was had about having a scan code as well as a URL code on signage in the entry of Havurah House to make sure visitors have access to the Zoom link for worshiping remotely. (With the inclusion of the URL the signage was approved)

John Harris is the tech contact for MFM (clarification as to who is in this role). This pertains to the risk of possible Zoom bombing and access/visibility of the Zoom worship link.

John Cook will do further research on the use of fans and air purifier systems for inperson meeting for worship.

21:11:07 - Due to time constraints, the following committees did not have time to report out in this Meeting for Worship with a Concern for Business: Ad Hoc Committee on Reviewing Draft Texts of NEYM F & P on Ministry and Counsel, Called Committee on the Urgent Call to Loving Action for the Earth and Her Inhabitants, Earthcare, Technology Committee, Fellowship, Pastoral Care, Library.

Fran Putnam recommended that in the future MFM should have a separate meeting for the annual budget review. Worship and Study will review this idea in the January meeting.

Other concerns, reports and matters were not heard due to time.

In the meeting house:

- A station with extra masks, hand sanitizer, and a small trash can.
- A small card for the greeter to hand out:

We respect that friends have different levels of risk aversion and need for social contact. Please make you own wise decisions based on the most recent data from the Vermont Department of Health. We protect one another as fully as possible. If you choose to attend in-person gatherings please be fully vaccinated, wear a mask, and arrange your chairs so that family/friendship pods leave distance between other people/groups.
